REAL ESTATE ASSOCIATE'S PROGRAM

This program must be completed in its entirety to meet the educational requirements for licensing in Alberta with the Real Estate Council of Alberta (RECA)

PHASE I

Introduction to a Career in Real Estate

\$125 with GST + 1 exam @ \$55.00 +GST

6-hr in-class session with home study & a 1½-hr exam

Min. exam grade of 70% required for each exam & no one of this class can be missed for this phase

There are no prerequisite for Phase I

PHASE II

Fundamentals of Real Estate

\$1,595 with GST + 1 exam: @ \$125.00 +GST

Sections 1-6: 16 days (96-hrs) & a 3-hr exam

Min. exam grade of 70% required for each exam & not more than 1 ½ days of classes can be missed for this phase

Phase I + transcripts + AREA form must be approved before registering in Phase II

PHASE III

Real Estate Areas of Practice

\$2,085 with GST + 3 exams @ \$125.00 each +GST

Section 7: (Residential) 7 days (42-hrs) & 3-hr exam

Section 8: (Commercial) 7 days (42-hrs) & 3-hr exam

Section 9: (Rural) 5 days (30-hrs) & 2½-hr exam

***Section 7 must be completed first*

Min. exam grade of 70% required for each exam & not more than a ½ day of class can be missed in each section

Phase II exam must be completed before attending Phase III

Getting Started

1. Fill out necessary forms with desired course dates, in person at the CREB® or online at: www.creb.com
2. After Phase I is successfully completed, AREA must receive & approve of education transcripts & registration before candidates can register for Phase II. As this can take longer than expected, transcripts should be requested as early as possible. There are no exceptions are made for this requirement
3. Phase II does not have to be completed to register for Phase III, however the Phase II exam must be written before candidates can attend Phase III
4. It is strongly recommended that candidates begin a certified criminal record check early, as this can take up to 6-months & is required for licensing
5. Once ALL phases are successfully completed, candidates may apply for the 3-day CREB® ORIENTATION session with Broker sponsorship
6. Once ORIENTATION is successfully completed, candidates apply for licensing at their brokerages
7. Licensed candidates are eligible to apply for CREB® Membership with MLS s& CLS access
